### The Opportunity:

The Secreto Self-Storage Team is offering a 665-Unit self storage development project nearing entitlements. The to-be-constructed facility is located at 1005 NE Stafford Street in Portland, Oregon. Lombard Storage is permit-ready.

The site is comprised of 3 tax lots that once purchased will require consolidation, resulting in one parcel of approximately 28,600 square feet.

A detailed feasibility study prepared in June 2020 reflects very strong demand in the area and will be provided upon execution of a non-disclosure/non-circumvent agreement.

- Served by four major arterial roads.
- Accessible directly off of Lombard Ave / Highway 30 Bypass that sees a daily influx of traffic between 21,006 - 27,700 vehicles.
